



Oklahoma Study Abroad Booking Conditions

Group Travel

Oklahoma Study Abroad will travel with a group of 10-30 travelers per trip. Often we will team up smaller university groups to ensure a full group. Groups are teamed up by age and course offered on the trip. For every 10 participants, Oklahoma Study Abroad will provide one gratis trip, equal to the student's trip, for the assigned group leader.

Pricing

Prices are based on foreign exchange rates current as of program pricing and are subject to change as exchange rates fluctuate. Use website as reference for program prices, as it will be most accurate to the current exchange rate.

Itinerary Variations

If improvements can be made to our itinerary or unforeseen circumstances require a change in the itinerary, Oklahoma Study Abroad reserves the right to amend the itinerary. Oklahoma Study Abroad will do their best to inform participants as soon as possible if any changes arise. These changes could involve change in the order of cities we visit or the amount of time we are spending in each city.

Booking Procedures

To reserve a place with one of Oklahoma Study Abroad's programs full program payment is due with application. Applications are processed on a "first come, first served" basis. Applications can be completed online at www.oklahomastudyabroad.com. All application deadlines are listed on www.oklahomastudyabroad.com and customers should refer to these dates and deadlines. Your application is not complete until Oklahoma Study Abroad has signed application and processed application. Travelers must be 18 years of age or older at the time of departure. Names should be provided as they appear on the participant's passport. This information will be used for hotel and transportation bookings.

Enrollment

We recommend that travelers enroll as soon as possible because tours tend to fill up quickly. Travelers should provide complete first, middle and last names and date of birth as they appear (or will appear) on their passport. Travelers can enroll online at www.oklahomastudyabroad.com through the "Sign Up Now" link on the website.

Refunds and Cancellations

Notice of cancellation will only be accepted from the applicant. The date of cancellation will be determined by the date upon which Oklahoma Study Abroad receives notification.

- The initial program deposit is non-refundable.
- A portion of the non-refundable deposit, varying based on each program, can be transferred to a future Oklahoma Study Abroad program.
- Remaining payments are fully refundable up to 45 days prior to departure. No refunds will be given for program cancellations within 45 days of departure.

Cancellation Replacements

If the initial applicant is not able to attend their program or cancels for other reasons, they can provide a replacement.

Group Leader Cancellation

A group leader must accompany participants on every tour. If a group leader cancels for any reason, he or she will be asked to assign a new group leader. The new group leader is responsible for any increases in his or her own airline costs. Any participants who cancel at this point and choose not to travel with their replacement group leader will be treated as standard cancellations. If no replacement group leader is found, the affected participants will need to cancel to be eligible for Oklahoma Study Abroad's Standard Cancellation Policy.



Passports and Visas

Each traveler must obtain a passport and any applicable visas for his or her tour prior to departure. If a traveler is unable to obtain these travel documents, they will not be allowed to travel. Passports must be valid for at least six months after the tour ends. Non-U.S. citizens will need to contact the embassy or consulate of their destination countries to ensure they meet specific entry requirements. This pertains to all countries that will be visited or passed through, including transfers between airports in foreign countries and re-entry into the United States. Insurance

It is recommended that all students have health insurance while traveling. Students are taught how to obtain local health insurance in the country they are visiting. Local health insurance is more affordable and guarantees coverage while the traveler is in that country. All-inclusive traveler's insurance can be arranged upon the school's request. Insurance is not included in the program price.

Making your own flight arrangements

Depending on the trip, Oklahoma Study Abroad may or may not book airfare for students. In the case of Oklahoma Study Abroad booking airfare, all quotes stand as an estimate until the group's full payment is received. On upper level trips, Oklahoma Study Abroad will not organize flights but only provide information on low cost airline ticket providers. Once a ticket is purchased by one of our students, we require a copy of the ticket to be sent to Oklahoma Study Abroad. This allows Oklahoma Study Abroad to observe flight times and provide assistance to our clients. Students are free to show up as early as they wish for a tour and stay as long as they wish after a tour. However, students must observe visa regulations and the amount of holiday time allotted to foreigners. Oklahoma Study Abroad offers an arrival check in window 2 days before program start date. This allows students flexibility with flight tickets and prices. During this two day period, for an additional fee not included in program price, Oklahoma Study Abroad will arrange accommodation for the student and either airport pickup from one of our local guides or information on how to get to place of accommodation. Once the program begins students will be staying in our pre organized places of accommodation. Oklahoma Study Abroad is not liable for any arrangements you have made on your own. If you are traveling on your own before your Oklahoma Study Abroad program and you don't request accommodation you are responsible for meeting your tour director at the 1st place of accommodation on the trips regular itinerary.



Flight Information

When traveling abroad we will fly from the closest international airport, unless more affordable airline tickets are available from other nearby airports. In this case, groups will be transported to and from the airport by coach.

What happens if my flight is delayed?

Oklahoma Study Abroad is not responsible for airline schedule changes or mechanical, weather, or capacity-related flight delays. We will resume the tour as soon as it is possible.

Student Rooming

Students on one of our travel programs will have roommates in their room the entire duration of the trip. Depending on city and event, rooms can range from 2-10 people of the same sex and same program. All places of accommodation are clean, safe, and up to Oklahoma Study Abroad's standards. We are a company for students and will, therefore, stay in student appropriate places of accommodation.

What happens if Oklahoma Study Abroad has to cancel a tour?

Oklahoma Study Abroad may cancel any tour for events beyond its control, including but not limited to instability in a destination country, acts of God, war (whether declared or undeclared), terrorist activities, incidents of violence, public health issues or quarantine, substantial currency fluctuations, strikes, government restrictions, fire or severe weather conditions which make it impossible or commercially unreasonable, in the opinion of Oklahoma Study Abroad, to conduct the tour. If Oklahoma Study Abroad cancels the tour for any such reason, participants will receive an Oklahoma Study Abroad Future Travel Voucher for all monies paid. Cancellation by Oklahoma Study Abroad for causes described in this section shall not be a violation of its obligations to any participant.

TERMS AND PROVISIONS

The terms and provisions of these Booking Conditions supersede any other warranties, representations, terms, or conditions, unless they are expressly stated within a Booking Conditions Addendum or in a letter signed by an Oklahoma Study Abroad officer. Prices are subject to change.



Legal Responsibilities:

Payment of the program fee constitutes consent to all the provisions of the conditions and general information contained herein. Oklahoma Study Abroad will occasionally document programs by photo or video. All parties consent to the use of the photos by Oklahoma Study Abroad unless they specifically request otherwise in written form. All programs begin at the meeting time and location listed in the program itinerary and end at the leaving time and location listed in the program itinerary. Any issues that may arise during the program pertaining to the program should be addressed by the program director. Oklahoma Study Abroad reserves the right to immediately remove any member of the program for failure to abide by regulations or directions of the tour director. Students who are removed from a program will not have the right to a refund of any amount and will not continue with the group. Oklahoma Study Abroad programs are not for resale and can only be enrolled in with Oklahoma Study Abroad. Oklahoma Study Abroad reserves the right to change any part of the program at anytime without notice. Oklahoma Study Abroad reserves the right to decline, or to accept or retain a person as a member of a program without notice. Oklahoma Study Abroad cannot be held responsible for events beyond its control, such as, (without limitation) acts of God, war (whether declared or undeclared), terrorist activities, public health matters, government restrictions or strikes: nor, in the absence of its own negligence, for personal injury, property damage, or loss of earnings, from any event whatsoever caused from persons not involved with Oklahoma Study Abroad, such as without limitation, airlines, cruise lines, railways, bus companies, all forms of transportation, places of accommodation, their employees and agents. Oklahoma Study Abroad makes every effort to ensure the accuracy of its publications, it cannot be held responsible for typographical or printing errors (including prices).

RELEASE AND AGREEMENT

1. My international tour is operated by Oklahoma Study Abroad.
2. My tour begins with the takeoff from the Oklahoma Study Abroad departure airport and ends upon completion of the flight back to the Oklahoma Study Abroad airport. I further understand that international travel involves certain risks to personal health, safety and property. Many foreign countries do not have the safety and health standards that are present in the United States. I am willing to accept the associated risks and understand that Oklahoma Study Abroad cannot guarantee the health and safety of participants in a foreign trip or eliminate the risk from a foreign environment.



3. I release and hold harmless Oklahoma Study Abroad and its affiliates (which term shall include parents, subsidiaries, officers, directors, agents and employees of as well as Oklahoma Study Abroad itself) and my school, my school board and group leader (the “Released Parties”) from, and agree not to sue the Released Parties for, any-and all claims, of any nature related in any manner to my participation in an Oklahoma Study Abroad sponsored tour, including but not limited to, claims for negligence, breach of contract, breach of express or implied warranties, or wrongful death. I hereby unconditionally and unequivocally waive any and all claims and demands for all damages, losses, costs and expenses of any nature whatsoever (including attorneys’ fees) on account of or arising out of any and all personal injury, death, bodily injury, mental anguish, emotional distress, property or other damage that I may suffer from any cause whatsoever related in any way to my participation in any Oklahoma Study Abroad sponsored tour. I further agree to release and hold harmless the Released Parties from any and all decisions to cancel, modify, or delay the tour as a result of acts of God, war (whether declared or undeclared), terrorist activities or threats of terrorists activities, instability in a destination country, incidents of violence, public health issues or quarantine or threats of public health issues, substantial currency fluctuations, strikes, government restrictions, fire or severe weather conditions that make it impossible or commercially unreasonable in the sole opinion of Oklahoma Study Abroad to conduct the tour. I further agree to hold the Released Parties harmless for the acts or omissions of any other individuals or entities over which the Released Parties have no direct or indirect control, including, without limitation, airlines, railways, bus companies, hotels, shipping companies, guides and sub-contracted agents or tour operators. I understand and acknowledge that Oklahoma Study Abroad does not own or operate any of the entities that provide goods or services on my tour. Without limiting the generality of the foregoing, I release the released parties from, and agree **NOT TO HOLD OKLAHOMA STUDY ABROAD, ITS OWNERS OR EMPLOYEES, PAST PRESENT AND FUTURE, LIABLE** for any bodily injury, mental anguish, emotional distress, physical or property damage, that I may suffer from the **OKLAHOMA STUDY ABROAD AND OR ITS EMPLOYEES** negligence other than from intentional or reckless acts.

4. The air carrier’s liability for loss of or damage to baggage or property, or for death or injury to person, is limited by their tariffs or the Warsaw Convention or both.



5. Oklahoma Study Abroad shall have no liability or responsibility for me when I am absent from Oklahoma Study Abroad-supervised activities or for non-Oklahoma Study Abroad supervised activities, such as visits to friends or relatives or during stay-ahead/stay-behind option periods if the stay-ahead/stay-behind period does not include the services of an Oklahoma Study Abroad Tour Director.

6. Oklahoma Study Abroad reserves the right to refuse or cancel my registration at their sole discretion. Group leaders may also refuse or cancel any participant's registration including my own. In such event, Standard Cancellation guidelines as outlined in the Booking Conditions apply.

7. I will abide by Oklahoma Study Abroad's regulations and the directions of my group leader, my tour director or Oklahoma Study Abroad's personnel during my tour. Regulations include but are not limited to Oklahoma Study Abroad's Rules of the Road, such as the prohibition of hitchhiking, the driving or renting of any motor vehicle, or having visitors of the opposite sex in students' rooms. Failure to do so may result in Oklahoma Study Abroad terminating me from the tour immediately. I understand that to disobey such rules or directions is to waive the right to a refund of any part of my Program Fee, and that Oklahoma Study Abroad may then send me home at my own expense.

8. I will abide by all local laws when abroad, including those concerning drugs and alcohol. Minors must have parents' permission to use alcohol even if the local law would otherwise permit them to. If parental permission to use alcohol has been granted, minors may only drink beer and wine (no hard liquor), and must be in the presence of the group leader. I understand that if I abuse or disobey such laws, even unintentionally, I waive my right to a refund of any part of the Program Fee, and Oklahoma Study Abroad may send me home at my own expense. I also understand that should local authorities be involved, I will be subject to the laws of the country I am visiting.

9. If I become ill or incapacitated, Oklahoma Study Abroad and its employees, or my group leader, may take any action they deem necessary for my safety and well-being, including securing medical treatment and transporting me home at my own expense. Oklahoma Study Abroad retains the right, in its sole discretion, to contact the participant's parent(s) and/or guardian with regard to health issues or any matter whatsoever that relates to participant's tour. These rights transcend any and all privacy regulations that may apply. In the event of a medical emergency, Oklahoma Study Abroad will attempt to cause appropriate treatment to be administered, and the participant authorizes Oklahoma Study Abroad to do so. Oklahoma Study Abroad, however, makes no warranty that it will be able to cause effective (or any) emergency treatment to be administered.



10. Oklahoma Study Abroad has the right to make changes in tour itineraries and departure dates, and to modify transportation arrangements, including the use of substitute airlines. In the event of such changes, refunds will be given only in accordance with the provisions of the Booking Conditions supplied herewith.

11. Prices are subject to unforeseen surcharges or price increases which, if imposed by airlines or other suppliers, will be separately billed.

12. By enrolling on this tour, I have made the choice to travel with the professor/group leader organizing my group, and I understand that this choice is not the responsibility of Oklahoma Study Abroad. I understand that my group leader is able to make decisions on my behalf, including but not limited to changing the group's requested tour or travel date and requiring that I purchase items such as insurance I understand that a group leader must accompany me on tour. If my group leader cancels for any reason, Oklahoma Study Abroad will ask him or her to assign a new group leader. If I cancel at this point and choose not to travel with the replacement group leader, I will be treated as a standard cancellation. If no replacement group leader can be found, I will need to cancel and Oklahoma Study Abroad's Standard Cancellation Policy will apply. I may also request that Oklahoma Study Abroad place me with a new tour group. If Oklahoma Study Abroad cannot find a new tour group for me, Oklahoma Study Abroad's Standard Cancellation Policy will apply.

13. It is my responsibility to secure the necessary travel documents (passport and visa[s]) unless specifically arranged for the group by Oklahoma Study Abroad. Failure to do so does not constitute grounds for a refund except according to the Standard Cancellation guidelines as outlined in the Booking Conditions.

14. I will be required to pay for any phone calls or incidental personal expenses that I incur at hotels, as well as for any damage I cause to hotel rooms, buses or other property.

15. This tour has been designed for students, as reflected in the pacing, educational content, accommodations and other aspects of the tour.

16. Oklahoma Study Abroad is not responsible for loss of passports, airline tickets or other documents, or for loss of or damage to luggage or any other passenger belongings. In the case of a lost paper airline ticket, the participant is solely responsible for meeting the airline's requirements (both logistical and financial) for ticket replacement.



17. I understand and agree that this agreement and Oklahoma Study Abroad Booking Conditions constitute the entire agreement between Oklahoma Study Abroad and me with reference to the subject matter and herein, and I do not rely on any promises, inducements, or agreements not herein, including but not limited to any oral statements made to me by any agents or any employees of Oklahoma Study Abroad, or by my school or school representatives. This agreement may be amended or modified only in writing, signed by both parties. The unenforceability or waiver by Oklahoma Study Abroad of any provision in this agreement shall in no way effect the remaining provisions of this agreement and this agreement shall be interpreted as if such clause or provision were not contained herein.

18. I understand and agree that this agreement shall be governed in all respects, and performance hereunder shall be judged under the laws and jurisdictions of the state of Oklahoma. In the event of any claim, dispute, or proceeding arising out of my relationship with Oklahoma Study Abroad or any claim which in contract, tort, or otherwise at law or in equity arises between the Released Parties, whether or not related to this agreement, the parties submit and consent to the exclusive jurisdiction and venue of the courts of OKLAHOMA COUNTY, State of Oklahoma.

19. The parties to this contract agree that any and all claims arising out of this contract or the performance of said contract will be settled by means of final and binding Arbitration with the American Arbitration Association (AAA) in accordance with the rules and procedures of the AAA. The parties knowingly and voluntarily waive any right to a jury trial.

20. All travelers must complete OKSA's medical form and be cleared by their physician for travel.
